TOTAL Deinstitutionalization of Status Offender (DSO) Core Requirement Violations

- 155 Juvenile Detention Centers (Accused status offenders held over 24 hours prior to an initial court appearance, or over 24 hours after an initial court appearance. Both time frames exclude weekends/holidays)
- 64 Juvenile Detention Centers (Adjudicated status offenders held without benefit of the Valid Court Order)
- 16 Adult Jails (any status offender held for any period of time, including warrants where the original offense was a status offense)
- 30 Adult Lockups (any status offender held for any period of time, including warrants where the original offense was a status offense)
- 265 Total Violations
