Dear DVOMB Approved Treatment Provider,

*The Domestic Violence Offender Management Board (DVOMB) is very excited about a new opportunity that provides an avenue for increased communication throughout Colorado among approved treatment providers.*

The DVOMB, through the Division of Criminal Justice, is implementing a Listserv for DVOMB Approved Treatment Providers. A listserv is a system designed to simplify the process of sending the same message to a group of people via email. The email is sent to the List's email address, and the List distributes the message to everyone who is subscribed to the mailing list.

The ListServ provides a way to pose questions, provide information, and have discussions regarding current topics related to DV offender treatment in Colorado.

If you are interested in subscribing to the DVOMB Approved Treatment Provider Listserv (dvombtx) please use the following instructions:

1. From the email address you would like to use for the listserv, send an email to [LISTSERV@CDPS-L.STATE.CO.US](mailto:LISTSERV@CDPS-L.STATE.CO.US) (type exactly as it appears-do not underline)  
Type the following in the SUBJECT line: **subscribe dvombtx**

Example email message:

To: [LISTSERV@CDPS-L.STATE.CO.US](mailto:LISTSERV@CDPS-L.STATE.CO.US)  
Subject: subscribe dvombtx



2. After sending that email:
- You will receive a “warning” or an “error” message” that will read:
  - **Only the List Admin can subscribe another individual to the list.** Ignore this message. This message is just saying that an administrator will review your request.
  - At this point, an administrator will review your request to be included on the ListServ to verify that you are an Approved Treatment Provider. Within one to five days, you will receive a welcome message from the Domestic Violence Offender Management Board Treatment Provider Listserv. This message will contain instructions and rules for use of the Listserv. It may be a good idea to print a copy of this message for future reference.

3. The welcome message will come from the email address of the listserv:[LISTSERV@CDPS-L.STATE.CO.US](mailto:LISTSERV@CDPS-L.STATE.CO.US)

4. To post messages on the listserv you will use the following address:

[DVOMBTX@CDPS-L.state.co.us](mailto:DVOMBTX@CDPS-L.state.co.us)

5. Only DVOMB Approved Treatment Providers may be on this list (dvombtx).

6. If you would like to unsubscribe to the listserv, you may do so at anytime. You would need to send an email to the listserv email address (as stated in item #3.) and type in the SUBJECT line: “unsubscribe dvombtx”.

Hopefully, Approved Treatment Providers will take this opportunity to connect with other providers, as well as having greater input into the work of the Board.
