Regarding: Proposed Revisions to *The Standards for Treatment with Court Ordered Domestic Violence Offenders, Standards 5.0 Offender Treatment and 6.0 Offender Confidentiality*

The Domestic Violence Offender Management Board (DVOMB) and its DV Treatment Review Committee have completed their proposed Revisions to *Standards 5.0 Offender Treatment and 6.0 Offender Confidentiality*. The next phase of these revisions is public hearings. The purpose of these public hearings is to obtain feedback from any interested stakeholders in Colorado regarding the proposed changes. The public hearings are not designed to be training on the proposed changes (trainings will be offered at a later date).
